- 5. Indian Vendors to confirm Inspection shall be done by BHEL/BHEL nominated inspection agency (TUV) as per BHEL approved Quality Plan.
 - 6. End of bars should be squared and sawed off properly.
 - 7. There should be proper stamping of cross section, Heat number, material grade, vendor code/vendor name on each bar at the pitch of one meter.
 - 8. Quantity tolerance should be ±10%.
 - 9. All vendors to provide point wise reply/confirmation along with relevant supporting documents to each and every point of Annexure (Pre-Qualification Requirement/PQR) for all enquiry items. 18. BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on https://www.bhel.com/) for this tender. RA shall be conducted among the techno-commercially qualified bidders.

Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking.

- 19. Vendor Contract clause regarding GST ITC and provision for E-Invoices w.e.f. 01.10.2020 for Indian Vendors:
- (i) W.e.f. 01.10.2022, vendor to ensure submission of E-Invoice who is having turnover of more than Rs. 10 Crs. in any preceding financial year from 2017-18 onwards.
- (ii) It has been specified by the Govt. that it is mandatory to mention a valid unique invoice Reference No. (IRN) and QR code as generated from Govt. portal on a Tax Invoice. - 20. For this procurement, the local content to categorize a supplier as a Class-I local supplier/ Class-II local supplier/ Non-local supplier and purchase preference to Class-I local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT.
- 21. 1. GENERAL.

2. ORIGIN OF QUOTATION.

- a) The quotation should preferably be from the principal bidder. However tender specific authorized registered dealer / agent can also submit the bid on their behalf, failing which the quotation is liable to be ignored. BHEL prefers to deal directly with the principal manufacturers.
- b) An agent cannot quote on behalf of more than one principal in the same Tender Enquiry.

3. SUBMISSION OF TENDER.

- C) In case of Three / Two Part Bid, technical bid containing technical offer, duly signed; and un-priced copy of the Price Bid should be kept in one envelope. Price Bid containing only the price should be kept in a separate envelope. All envelopes indicating Part-1 or Part-2 or Part-3 as the case may be to be put in a bigger envelope. Please note that un-priced bid should be the exact replica of price bid but without prices.

4. TENDER OPENING.

- d) Any demurrage / Godown Rent payable to the Port Authorities due to any delay attributed by the supplier will be recovered from supplier's account.
- e) A certificate of origin (COO) sanctioned in country of origin from chamber of commerce of the manufacturing country is to be provided mandatorily. However, a certificate of origin (COO) from the countries under the restricted list of Govt. of India will not be acceptable.

11. BANK GUARANTEE.

12. GUARANTEE / WARRANTY AND CORRESPONDING REPAIRS / REPLACEMENT OF GOODS.

If no creep rupture is occurred after 100 h, the proof stress can be increased for further 30 MPa after every 24 h, until the creep rupture occurred.

7.2.2 Grain Size Check:

The metallographic examination has to be carried out at the beginning and at the end of the hardest and softest bar and in each case in the corner and in the center of the cross section. A substantially homogeneous microstructure with a grain size 3 -6 according to ASTM E 112 has to be achieved in the cross section. A grain size DUPLEX ALA 3 according to ASTM E 930 is acceptable provided, that a grain size of 1 is not exceeded. A deviating microstructure has to be documented according to ASTM E 1181 and to be approved by the BHEL. Reduction of amount of testing can be agreed with the BHEL. For this purpose the manufacturer has to provide adequate results.




